Every day or portion thereof during which any violation of the Municipal Code or any other ordinance of the Town is committed or continues may constitute a separate offense.

Until paid, all rates, and other charges provided for in this article shall constitute a lien pursuant to C.R.S. 31-15-302 on or against the property being served. Section 15-85 Bayfield Town Code.
